The Clarksburg City Council met in REGULAR SESSION on Thursday, April 19, 2018 at 6:00 P.M. at the Clarksburg Municipal Building – Council Chambers, 222 West Main Street, Clarksburg, West Virginia, with Mayor Goings presiding.

Following roll call, the prayer and pledge were led by Councilmember Kennedy.

Council deviated from the agenda for the following presentation:

Mayor Goings presented a proclamation to Clarksburg-Harrison Regional Housing Authority Director Lou Aragona proclaiming April as "Fair Housing Month" in the City of Clarksburg. Mr. Aragona provided Council with the Authority's Annual Report for 2017 and discussed the same in detail noting the Authority's once again "high performer" rating. Mr. Aragona presented the Mayor with the PILOT payment check in the amount of \$62,006.94.

MOTION by Councilmember Goff, **SECONDED** by Councilmember Sigmon for approval of the minutes of the Regular session of Council held on April 5, 2018. **MOTION APPROVED UNANIMOUSLY.**

Mayor Goings called for petitions, communications and public hearings with no one appearing therefor.

AGENDA ITEM NO. 5: CITY MANAGER'S REPORT/UPDATE

Manager's Report April 19, 2018 Submitted by Martin G. Howe

General Updates

- Spring Clean-up As of Wednesday, April 18th, the Public Works Department has collected 135.49 tons and has made 128 trips to Landfill using various Public Works trucks with a Landfill tipping fee cost of \$5,151.66. This particular Clean-Up is 36% less than in tons for first eight (8) days in comparison to the most recent October 2017 Fall Clean-Up. The Clean-Up concludes on Friday, April 27th.
- Road Slippage The City is currently in the process of advertising a Request for Proposal (RFP) from
 engineering firms to provide engineering services to assist with addressing the road slips throughout the
 City. All proposals from interested firms are due by Monday, April 30th. The administration will
 interview interested firms and then negotiate a contract for Council to consider at its meeting tentatively on
 Thursday, May 17th.
- 3. DOH
 - a. Northview Overpass Field Review Meeting was conducted on-site on Tuesday, April 10th.
 Assistant City Manager, Anthony Bellotte, attended the meeting. A public meeting will be scheduled this summer for public comment.
 - b. Street Issues City continues to communicate with DOH regarding conditions of State owned and maintained roadways within City (Main Street/Pike Street, Milford Street, Rt. 98, Joyce Street/Marshall Street/Buckhannon Pike). DOH crews have been out this past week working on these streets.
- 4. City Streets
 - a. Public Works Department has begun using hot mix asphalt now that the plants have opened for operation. The City crews have been in the neighborhoods making appropriate road repairs along with sweeper operation and Spring Clean-Up.
 - b. All utility companies (Water Board, Dominion, Frontier) will be contacted to inform them to return to all utility cuts made over the winter and replace and repair with concrete and asphalt.
 - c. Public Works crews are in the process of cleaning approximately fifteen (15) streets that were affected by the recent flood waters.

Economic Development

- 1. Robinson Grand Performing Arts Center
 - a. Window installation in Ballroom is complete.
 - b. HVAC installation in the Ballroom is complete.
 - c. Installation of wall tiles in first and second floor restrooms is approximately 99% complete.
 - d. Installation of wall assembly around the ADA ramp in the Lobby is approximately 98% complete.
 - e. Framing of upper Balcony Box Seats is approximately 80% complete.
- 2. TIF Funds Administration is proposing to replace 577 linear feet of sidewalk and curb on W. Pike Street, N. 6th Street and Hewes Avenue. In addition, there will be installation of conduit and pull boxes installed for future new street lights. The administration recommends Council approve expenditure for \$123,668 from TIF funds and not to exceed \$125,000.
- 3. Ribbon Cutting Taqueria Lou Lou (Mexican Restaurant), Tuesday, April 24th at 11:00 a.m., located at 1404 W. Va. Avenue.

Boards/Commissions

Planning and Zoning Commission – The City Manager is (re) appointing Patrick Shaffer to the P & Z Commission. This appointment is on Council's agenda under new business for confirmation.

Police

- 1. Police
 - a. Testing
 - i. Physical ability test was held on Saturday, April 14th. A total of eleven (11) appeared to participate and six (6) passed.
 - ii. The written test is scheduled for Wednesday, May 2nd.
 - iii. Another physical ability test will be on Saturday, May 5th.
 - b. Taser Training 37 officers were certified for use of tasers throughout the week and 30 officers will be issued tasers. This was made possible with the additional funding provided by Council.

PIKE STREET AND HEWES AVENUE FROM N. 6^{TH} STREET TO EAST SIDE OF 444 W. PIKE STREET UTILIZING TIF FUNDS IN AN AMOUNT NOT TO EXCEED \$125,000
