General Updates

- 1. Chestnut Street Project This final phase of the project is currently out to bid. The bids will be due by 10:00 a.m., Tuesday, June 27, 2017 at the DOH Office in Charleston. Completion is scheduled for Friday, September 29th.
- 2017 Paving Program The annual paving project is currently out for sealed bid. The bids are to be submitted by 2:00 p.m. on June 29th. We anticipate the award of bid will be on Council's Agenda for consideration at the Thursday, July 6 meeting.
- 3. City Hall Server an additional 24 Terabytes will be installed in our server for video storage for all City Hall Camera's.

Economic Development

- 1. Robinson Grand Performing Arts Center
 - a. The basement floor has been installed for the new West addition. The elevator pit has been backfilled with stone and the formwork for the walls has been installed.
 - b. The additional steel support installation for the ballroom floor bar joists is complete.
 - c. The underground plumbing has been installed in the front lobby area.
 - d. Sprinkler line installation is approximately 45% installed.
- 2. Ribbon Cutting/Open House Highland Hospital Tuesday, June 21, 2017 at 3pm Open House for the new Imagination Playground. The Open House will begin at 4:45pm with the Chamber After Hours to follow 5pm-7pm.
- 3. Clarksburg Uptown continuing with their beautification efforts have begun the installation of the window clings on the former Country Kitchen Building.

1. Fire -
